MINUTES OF THE COMMITTEE OF THE WHOLE MEETING, MARCH 8, 2016

The meeting of the Board of Education, School District 123, Cook County, Illinois, convened at 6:01 p.m. on Tuesday, March 8, 2016 at the Oak Lawn-Hometown Middle School, 5345 W. 99th Street, Oak Lawn, Illinois.

Open Session The meeting was called to order at 6:01 p.m., roll call was taken with

each member being present except Mr. DeRousse.

The Pledge of Allegiance was said.

Mr. Mason read the Mission Statement.

Public Comment President Mason stated that citizen comments were allowed to address

the Board. Public comment was to be limited to 15 minutes with each

person being limited to three minutes.

Candace Hines shared progress made and remaining concerns

regarding the Special Education program.

Dr. Enderle addressed the Board stating that the staff of a co-teaching

model, program supervisors and a full time behavioral consultant will significantly and successfully support this program next year.

Mr. Mason commented that the Board approved the A.E.R.O. withdrawal in order to bring back the District's students and teach them in the least restrictive environment in their neighborhood schools

making sure that the delicate balance of support is in place.

There were no additional speakers; President Mason declared public

comment closed.

Discussion: Assistant Superintendent Loftin discussed the final document of the

performance contract with CTS. There were no questions or comments.

It was moved by Mr. Lurquin, seconded by Mrs. Misner to approve the performance contract with CTS. Voting aye: Mr. Nichols, Mrs. Misner, Mr. Lurquin, Ms. Roche, Mrs. Fortier and Mr. Mason.

Nay: None. The motion carried.

Discussion: Dr. Enderle explained that associated with the CTS contract is a ten

percent mobilization fee, which provides CTS the money to order supplies and begin the process due to early planning. Assistant

Superintendent Loftin originally budgeted the funds to be subtracted

from the Construction fund, but at the Board's request will perform a journal entry to direct the funds to be deducted from the Operational fund.

It was moved by Mr. Lurquin, seconded by Ms. Roche to approve the payment of \$142,725 for the contractual mobilization fee. Voting aye: Mr. Nichols, Mrs. Misner, Mr. Lurquin, Ms. Roche, Mrs. Fortier and Mr. Mason. Nay: None. The motion carried.

Discussion:

Superintendent Enderle introduced Joel Craig, Superintendent of Parks and Dolly Foster, Horticulturist from the Oak Lawn Park District who discussed a potential partnership and community garden. This community garden will be located at the Senior Center and the McGugan School site. The garden site will be divided into two sections which would include a pantry garden, which would supplement surrounding food pantries and allotment plots which would be for rent by the public. Along with the allotment garden will be a pollinator garden, which is the essential element of any garden and will raise the yield of the efforts in planting. The area will be just under a half of acre at 21,976 square feet. There will be 88 accessible beds.

Board Comments:
